August 24, 2009 Inaugural Class of 60 students begins instruction.

June 6, 2014 The American Bar Association grants full accreditation.

### 2018

January 1, 2018 L. Song Richardson becomes the second dean.

March 2018 U.S. News & World Report ranks UCI Law No. 21 in the country, out of 194 law schools.
